IF YOU DO NOT AGREE WITH ANY PART OF THIS AGREEMENT, YOU MUST IMMEDIATELY CEASE USAGE OF THE MATERIALS. FOR THE PURPOSES OF THIS AGREEMENT, THE TERM "YOU" INCLUDES BOTH YOU THE READER AND ANY CORPORATE ENTITY WHICH EMPLOYS YOU OR WHICH YOU REPRESENT ("CORPORATE LICENSEE").

#### 1. LICENCE

Provided that you have paid the agreed licence fee(s), Epix grants you a limited non-exclusive licence to use The Materials. You assume responsibility for the selection of the software to achieve your intended results, for its correct use and for the results obtained from the software.

You may :

- a) subject to any agreed limits to the numbers of users, use The Materials on any computer system owned, leased and/or controlled by you or any member of your corporate group, which expression includes the Corporate Licensee, the Corporate Licensee's majority-owned subsidiaries, any parent company having a majority-owned interest in the Corporate Licensee, and such parent's majority-owned subsidiaries; and
- b) make copies of the associated documentation for the sole purpose of assisting you in the correct usage of the software.

#### 3. LICENCE RESTRICTIONS

You may not use, copy, modify or transfer the Materials or any copy, in whole or in part, including any print-out of all or part of any database, except as expressly provided for in this licence. If you transfer possession of any copy of the Materials to another party except as provided above, your licence is automatically terminated. You may not translate, reverse engineer, decompile, disassemble, modify or create derivative works based on the Materials, except as expressly permitted by the law of this Agreement. You may not use screen scrapers, key loggers, key pressers or any other non-human methods of interacting with The Materials. You may not vary, delete or obscure any notices of proprietary rights or any product identification or restrictions on or in the Materials.

#### 4. SOFTWARE UPDATES AND SUPPORT

- a) Epix is under no obligation to make any software updates of whatsoever kind or to inform you of the publication or existence or availability of any such updates.
- b) Epix may from time to time elect (at its sole discretion) to produce updates for the purpose of correcting errors or omissions, or for the purpose of enhancing the functionality or performance of the Materials.
- c) If Epix produces any such updates from time to time, Epix will make such updates available to you, which may be chargeable at the then current update prices and terms and conditions of sale.
- d) Epix may from time to time, and at its sole discretion, introduce (or subsequently withdraw without notice) technical support and/or training services and facilities. Epix may offer any such services to you at the then current prices and terms and conditions of sale.
- e) Notwithstanding the previous clause, where the agreement to provide the Materials includes support and / or hosting, Epix shall continue to supply the same until this licence is terminated. You will renew and pay for said support and / or hosting at each anniversary, failing which this licence will automatically terminate.

#### 5. UNDERTAKINGS

You undertake to:

- a) ensure that, prior to use of the Materials by your employees or agents, all such parties are notified of this licence and the terms of this Agreement;
- b) reproduce and include our copyright notice (or such other party's copyright notice as specified on the Materials) on all and any copies of the Materials, including any partial copies of the Materials;
- c) hold all drawings, specifications, data, software listings and all other information relating to the Materials confidential and not at any time, during this licence or after its expiry, disclose the same, whether directly or indirectly, to any third party without the prior written consent of Epix.
- d) respect and acknowledge that all rights, title and interest (including but not limited to copyright and all other intellectual property rights) in the Materials are the sole and exclusive property of Epix, its suppliers and in some cases other parties.

#### 6. LIMITED WARRANTY

Epix does NOT warrant that the Materials will be free from errors. Any Materials found within twelve months of purchase to contain errors will, at Epix's sole discretion, be either replaced or repaired, or refunded, provided that Epix are notified in writing within the said period giving full details of such errors. This undertaking to replace, repair or refund shall be the full extent of Epix's liability and in no event will Epix be liable to you or any other parties for any damages including any lost profits, lost savings or other incidental or consequential damages arising out of the use or inability to use The Materials even if Epix has been advised of the possibility of such damages or claims.

Epix warrants that the media on which Materials are supplied is free from defects in materials and workmanship at the time of supply. Epix's liability in the event of any breach of this warranty shall be to replace without charge or refund (at its sole discretion) any defective media returned to it within ninety days from the date of delivery, and to refund any postage costs incurred in returning defective media. This warranty does not oblige Epix to replace media damaged through misuse or neglect.

Except as aforesaid, all warranties, conditions or otherwise and whether arising under the contract of sale, or under any prior agreement, or in oral or written statements made by or on behalf of Epix in the course of negotiations, are hereby excluded. Under no circumstances shall Epix be liable for any direct, indirect, consequential or incidental loss or damages or injury of any kind whatsoever (including, without limitation, loss of revenue, contracts or profits) or for any damage to or destruction of property, however caused or arising and whether or not as a result of negligence except for death or personal injury caused by the negligence of Epix.

#### 7. TERMINATION

The licence is effective until terminated. You may terminate it at any time by destroying the Materials together with all copies in any form. It will also terminate upon conditions set out elsewhere in this Agreement or if you fail to comply with any term or condition of this Agreement or if you voluntarily return the Materials to us. You agree upon such termination to destroy the Materials together with all copies in any form.

Without prejudice to any other provision contained within this Licence Agreement or of any Agreement Epix may terminate the Agreement by notice in writing in any of the following events:

- a) you commit a material breach of the Agreement which is incapable of remedy; or
- b) you commit a material breach which is capable of remedy but which you fail to remedy within 14 days of written notice by Epix specifying the event of default and requiring its remedy.

Either party to this licence agreement may by notice in writing to the other terminate the agreement if the other shall have a receiver or liquidator appointed, shall pass a resolution for winding up (otherwise than for the purpose of amalgamation or reconstruction), if a Court shall make an order to that effect, if the other party shall enter into composition or arrangement with its creditor(s) or shall become insolvent. Such an event shall be deemed to be a material breach incapable of remedy.

Any termination of the licence agreement howsoever caused shall not affect any accrued rights or liabilities of either party arising out of the Agreement.

#### 8. EXPORT

You will comply with all applicable laws, rules, and regulations governing export of goods and information, including the laws of the countries in which the Materials were created. In particular, you will not export or re-export, directly or indirectly, separately or as a part of a system, the Materials or other information relating thereto to any country for which an export licence or other approval is required, without first obtaining such licence or other approval.

#### 6. GENERAL

- a) The Materials are licensed only to you. Except as provided for above you may not rent, lease, sub-license, sell, assign, pledge, transfer or otherwise dispose of the Materials, on a temporary or permanent basis, without the prior written consent of Epix.
- b) Failure by Epix to enforce any of the rights herein shall not be deemed to be a waiver thereof.
- c) Each of the provisions of this licence is severable and the invalidity or unenforceability of any one or more of them shall not effect the enforceability of the remaining provisions hereof.
- d) This licence will be governed by the laws of England.
